

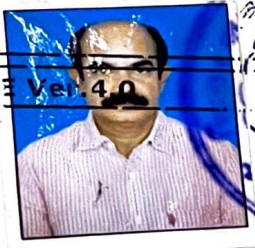

5. That the Trustees shall always maintain proper accounts of the Trust which shall be kept at the office of the Trust.

6. That for the furtherance of the objects of the Trust, the Trustees shall have the following powers :

a. To open account or accounts in the name of the Trust, Trustees and / or Institutions run / conducted by the Trust with a Bank or Banks, Government/Non-Government financial institution, to operate such accounts and to give instructions to such Bank/Banks/financial institution and to provide for opening and operation of such accounts by two Permanent Trustees or by one or more Trustees authorized by them or by an agent appointed by them.

b. To seek and accept subscriptions, donations, contribution, grants, loans, gifts and bequests, in cash or kind, from any person(s), body of persons, firm, company, corporation, institution, Local, State or Central Government/Authority, with or without conditions.

c. To accept or acquire by gift, purchase, exchange, lease or hire or otherwise lands, buildings, basements, playgrounds, parks and asset/property, movable or immovable, for or in the name of the Trust for the furtherance of any or all objects of the Trust.

d. To negotiate with and enter into agreement, contract or arrangements with any Government/Authority/University/College/Institutio

To apply to the Government, public bodies, urban, local, municipal, district and other bodies, corporation, companies, or persons for and to accept grants of money and of aid, donations, gifts, subscriptions, and other assistance with a view to promote the objects of the Trust and to discuss and negotiate with the Government Departments, public and other bodies, corporations, companies or

10. The number of the Trustees shall not be less than two and more than five. If the number of the Trustees shall fall below two, the Trustees shall not, except for the purposes of filling any vacancy, act so long the number is below the said minimum.

11. The Permanent Trustees for the time being will be at liberty to appoint Co-opted Trustee-whose number will not be more than three-for such period or on such terms as to retirement and re-appointment as the Permanent Trustees consider proper.

- (a) Two Trustees shall form a quorum for a meeting of the Trustees.

- (c) Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the Trustees shall be as valid and effectual as a resolution duly passed at a meeting of Trustees.

purpose which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly,


