The Trustees shall be accountable only for such moneys, stocks, shares and funds as shall actually come into their hands and a Trustee shall not be answerable or accountable for neglect, default, acts of omission or commission of the other Trustees, nor of any banker or other person with whom the Trust properties or any securities may have been deposited or kept.
- 8. The Trustees will not be entitled to receive any remuneration, but the Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.

The First Trustees named in this Deed will be the Permanent Trustees during their lifetime and each of them may nominate his / her successor to become the Permanent Trustee in his / her place after his / her demise or

incapability. If the said Permanent Trustee fails to nominate his / her successor, one of his / her legal heirs, in order of the superiority in age, will be his / her successor.

- 10. The number of the Trustees shall not be less than two and more than five. If the number of the Trustees shall fall below two, the Trustees shall not, except for the purposes of filling any vacancy, act so long the number is below the said minimum.
 - 11. The Permanent Trustees for the time being will be at liberty to appoint Co-opted Trustee-whose number will not be more than three-for such period or on such terms as to retirement and re-appointment as the Permanent Trustees consider proper.
 - 12. A person shall cease to be a Co-opted Trustee if he / she is requested to resign by two-third or as near thereto as possible of the remaining Trustees.
 - 13. Any Co-opted Trustee may also be removed if he/she
 - a. becomes of unsound mind;
 - is convicted of any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than six months;
 - c. absents himself from three consecutive meetings of the Trust without prior permission of the Trustee Chairman
 - d. is absent from India for a continuous period of more than six months without prior permission of the Trustee

- 14. Every Trustee, including the Permanent Trustees, will be at liberty to resign on giving one month's notice of his/her intention to do so.
- Trust and will represent the Trust either personally or though a person authorized by him. The Trustee Treasurer shall exercise such power as are delegated to her by the Trustee Chairman and will discharge such responsibilities as are assigned to her by the Trustee Treasurer.  - (c) Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the Trustees shall be as valid and effectual as a resolution duly passed at a meeting of Trustees.




